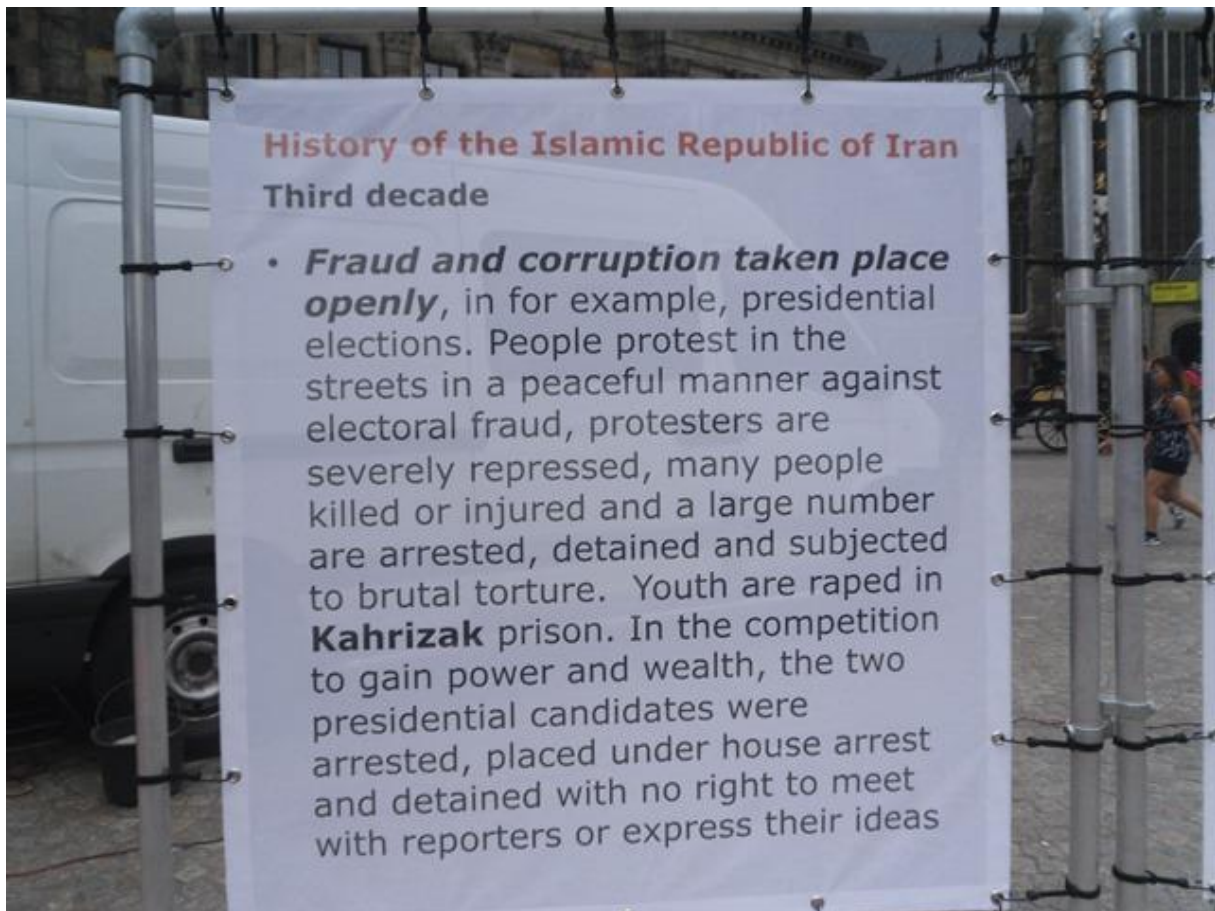
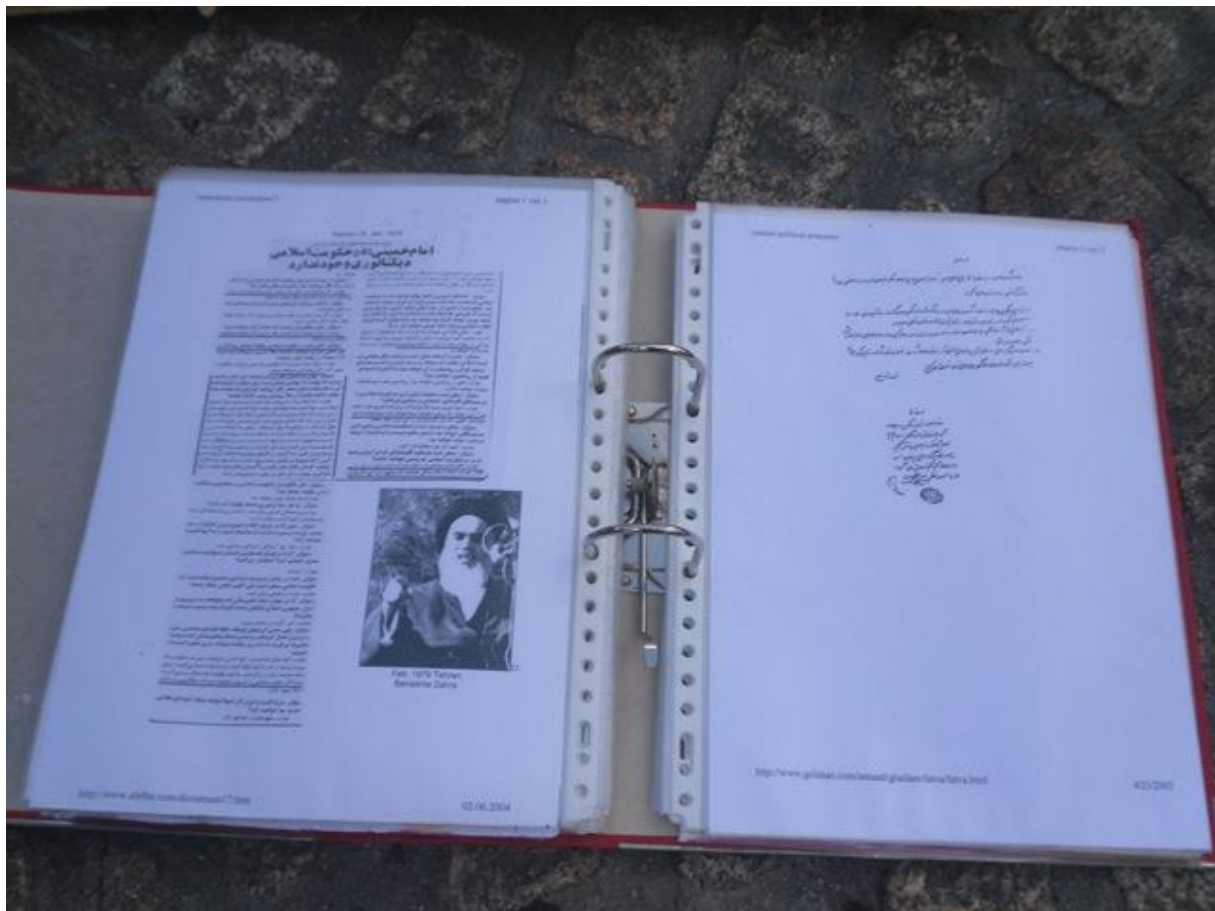

The 1988 mass executions of political prisoners in Iran

The 1988 mass executions of political prisoners in Iran refers to the state-sponsored execution of political prisoners across Iran, starting on 19 July 1988 and enduring for approximately five months.

Great care was taken to keep the killings undercover.

There was a formal **FATWA** issued by Khomeini the supreme leader of Islamic Republic.

Khomeini insisted that there should be no mercy shown and ordered that all prisoners, including even teenagers and pregnant women, be put to death immediately.

Executed prisoner's families were told: "for one year you shall refrain from holding a funeral, or mourning their deaths in any public way. If after one year your conduct is deemed acceptable, we will reveal to you their places of burial."

They were called one-by-one in front of a makeshift court made up of an Islamic judge, a state prosecutor and a representative of the Ministry of Intelligence.

They were asked:

-Are you a Muslim?

-Do you pray?

-What is your political affiliation?

-Do you believe in Islamic Republic or not?

-Do you recant your beliefs and political activities?

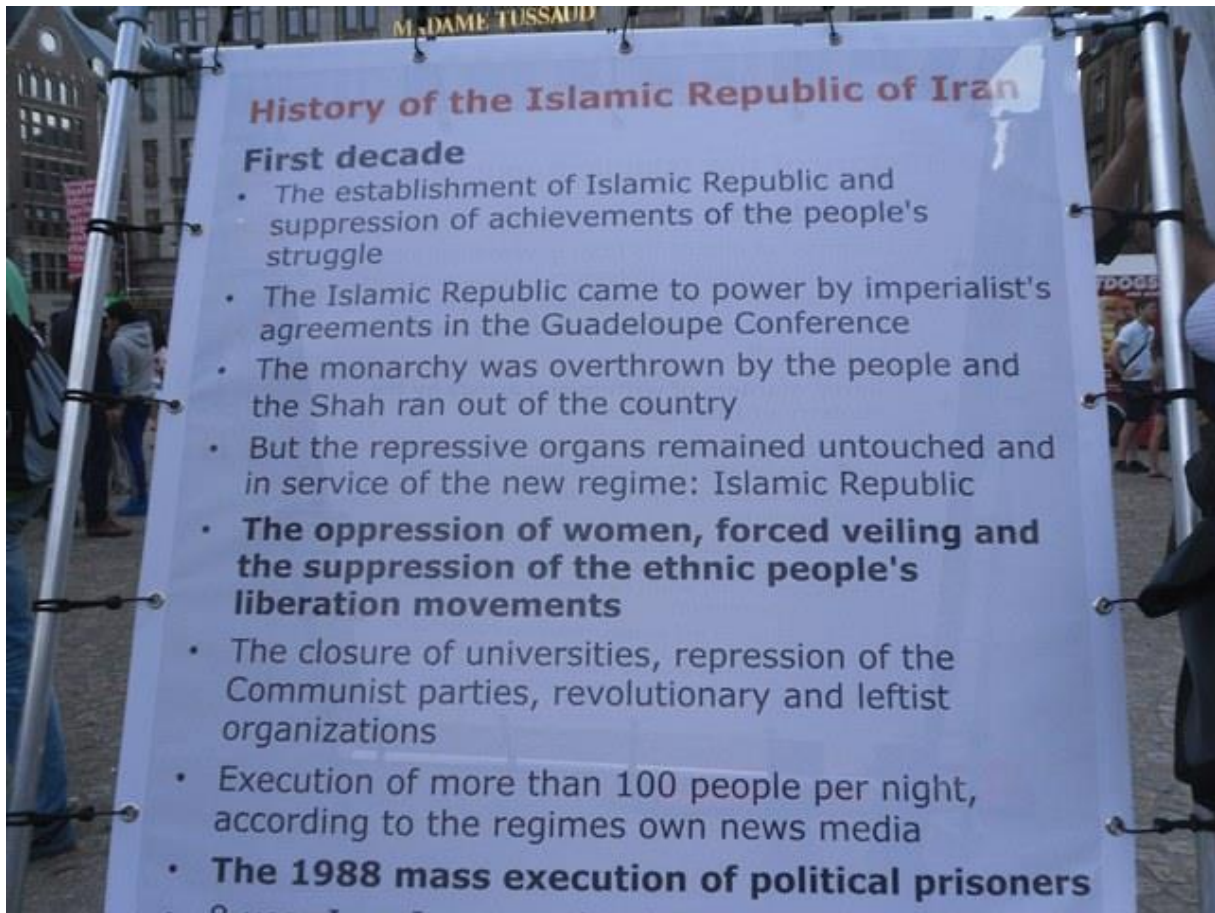
If their answers didn't satisfy the court they were sent for execution.

On the 28th anniversary of one of the most hideous crimes against humanity since the Second World War, time has come to call for those responsible for to be held to account.

History of the Islamic Republic of Iran Fourth decade

- Finally, at the time of worsening crisis and the possibility of mass revolts, the Islamic Republic has been forced to fully accept the conditions set by the Joint Comprehensive Plan of Action (JCPOA) with humiliation and has had to spend millions to stop its atomic project. After accepting the JCPOA and the lifting of parts of the sanctions by the US government, the Rouhani government promised to solve high prices, unemployment, inflation and other economical problems. However, during 3 years of presidency not only the JCPOA has failed to solve or alleviate any of people's many problems but also destitution and misery, arrests and tortures and executions of dissidents has gravely increased so much so that the new president has been labelled the Champion of Executions. The numbers of those sentenced to death recently reached to 4 per day. **Many political activist get executed among those accused of drug dealing.** The families of political activist are not allowed of holding any memorial, not even religious ceremonies.
